D. 1875, and it appearing further that the copy of said Will here presented bears the signature of Daniel Humphrey late Probate Judge of said County of Licking, certifying the same to be a true and correct copy of said original Will together with the seal of said Court, affixed thereto.

ABNER GOFF'S WILL

I, Abner Goff of the County of Licking and State of Ohio being of sound mind do make and publish this my last Will and Testament.

First: I give and devise to my beloved wife Patty and my daughter Sarah the farm on which we now reside, containing about ninety nine acres more or less to be held and occupied by them as joint tenants in common during the natural life of my wife, Patty, and all the Stock Household goods, furnature, provisions and other goods, and chattels which may be thereon at the time of my decease they however selling so much thereof as may be sufficient to pay my just debts. And at the death of my wife all my personal property that is not consumed and expended, I bequeath to my Daughter Sarah.

At the Death of my wife I give and bequeath to my Daughter Sarah all that part of the Farm on which we now reside, lying and being South of a line commencing eight feet, east of the centre of the Rail Road track, sixteen rods south of the north East corner of my farm, above noted, and running West parallel with my north line to my west line to have and to hold the same to her and her heirs forever.

Second: I do hereby nominate and appoint Jacob Wright of the Tp. of McKean and County of Licking and State of Ohio Executor of this my last Will and Testament, hereby authorizing and empowering him to compromise, adjust, release, and discharge in such manner as he may deem proper, the debts and claims due me.

I do also authorize and empower him at the death of my said Wife to sell by private sale, or in such manner and upon such Terms of Credit or otherwise as he may think proper all of my real estate not herein given and bequeathed to my Daughter Sarah, and the proceeds of said sale, to be equally divided and distributed among my legal heirs, not named in this my last Will and Testament, and also to Execute deeds to purchasers, Acknowledge and deliver the same in fee simple. I do hereby revoke all former Wills by me made.
